Membership Admissions Policies

March, 2023

An application fee of \$50.00 must accompany all applications to cover the costs of administering applications, but there will be no annual fee to remain on the waiting list.

Applications received by the Club will be collected and held by the Chair of the Membership Committee. When openings occur, those applicants at the top of the list would be invited to come for an interview. After the interview, the Chair of the Membership Committee would bring the applications and the results of the interview to the Board of Governors for disposition.

Applicants (with their sponsor in attendance) would be interviewed by the Chair of the Membership Committee and one other Board member with the purpose of determining their reasons for joining the Club and the likelihood they would participate in Club activities in one or more of the following ways:

- Racing
 - Have you raced elsewhere?
 - Do you have specific plans to race with a current member of the Club?
 - Will you bring a new boat into the Cape Cod Knockabout fleet?
- Cruising
 - Do you own a boat?
 - Where do you keep it now?
 - Are you planning on buying a boat in the next year or two?
 - Do you have a mooring in Great Harbor? In Eel Pond? Elsewhere?
 - Do you intend to keep a skiff or a rowboat at the Club or nearby?
- Participation in Club social activities
 - How do you intend to take part in the social life of the Club?
 - Are you a member of other social organizations?
 - Are you on the board of those organizations?

Applicants would have to show a strong intent in participating in Club activities in one of the above ways in order to be accepted.

Sponsors of new members will be expected to introduce them to the membership at the Commodore's Party and/or other Club social events and to otherwise encourage them to participate in Club activities.

Club. Such Member further agrees that it will indemnify and hold harmless the Club and its employees, agents, servants, and Members, and their successors and assigns, against all claims for such loss, damage, or injury sustained by anyone arising out of such use of the Club property, facilities, or activities at the invitation and/or with the permission or consent of the Member.
